**Terms for Commercial**  
**Photography / Videotaping / Filming / Recording**

The State of Alaska, Department of Transportation and Public Facilities, Ted Stevens Anchorage International Airport ("Airport") consents to commercial photography, videotaping, filming and any other sound or image recording ("Photography/Recording") to take place on or about the following date(s): \_\_\_\_\_, by \_\_\_\_\_ and its agents and employees (collectively "Photographer/Recorder") and to use the resulting images and audio recordings for commercial purposes conditioned upon the following terms, and any activity relating to Photography/Recording by the Photographer/Recorder shall be deemed conclusive acceptance of these terms by the Photographer/Recorder:

1. Vehicles parked at terminal curbside may not be left unattended; vehicle parking shall be limited to the Airport's public parking lots at the established fee rates.
2. Equipment bags may not be left unattended in the terminals.
3. Photographer/Recorder and all personnel involved in or in support of the Photography/Recording must
  - Provide, set-up and remove all equipment used in conjunction with the Photography/Recording;
  - comply with all security directives and security employees;
  - comply with all Federal, State and local laws, statutes, ordinances, rules and regulations governing operation and security of the Airport, including, but not limited to, regulations promulgated by the Federal Aviation Regulations and Transportation Security Regulations, as well as all onsite directives by the Transportation Security Administration ("TSA");
  - while on Airport property (except when in front of the camera during actual Photography/Recording) wear an identification badge provided by \_\_\_\_\_ that displays the person's name, and the name of the group or organization to which the Airport has given the release for Photography/Recording;
  - not smoke inside any Airport building or in any outside area designated as a no-smoking area.

4. The Photography/Recording and all relating activity must be performed in a manner that does not materially
  - impair the safe and efficient operation of the Airport, disrupt travel, impair security measures, or materially increase congestion at the Airport;
  - pose a hazard to public health or safety;
  - interfere with passenger, cargo or flight operations at the airport;
  - photograph any Airport User without such Airport User's consent ;
  - obstruct, impair or interfere with the free movement of pedestrian or vehicular traffic, or the conduct of any authorized business at the Airport
  - engage in Photography/Recording activities other than the location(s) identified in writing in to the Airport in advance of Photography/Recording, which are (1) the non-secure public area of the South Terminal; and (2) to the extent allowed by the TSA and in compliance with all applicable security limitations, in the secure public areas of the South Terminal (Photographer/Recorder acknowledges that the Airport has no authority to and does not purport to give permission for filming aboard any aircraft);
  - annoy, disturb or be offensive to others at the Airport, or that is not clean and orderly.
5. The Airport makes no representation or warranty concerning the suitability of any Airport property or facilities for the exercise Photography/Recording or any other matter. By engaging in Photography/Recording-related activities on the Airport, the Photographer/Recorder expressly assumes all risks relating to weather for Photography/Recording, suitability of location and all other matters with respect to activities on the Airport other than public use of the Airport in conjunction with the transportation of the Photographer/Recorder.
6. Nothing herein is intended, or shall be construed, to grant any person rights to conduct Photography/Recording in areas of the Airport exclusively or preferentially leased to any Airport tenant, without the prior express written consent of such tenant.
7. Upon receipt and review of all bona fide written claims, Photographer/Recorder shall promptly pay all costs of repair or replacement of any Airport property damaged by Photographer/Recorder's operations. Photographer/Recorder shall make no improvements or alterations to Airport property without prior approval, in writing, by the Airport.
8. Non-Discrimination. Photographer/Recorder agrees that no person shall be excluded from participation in, denied the benefits of, or otherwise discriminated against in connection with Photographer/Recorder's activities at the Airport because of race, color, religion, national origin, sex, age, handicap or political belief or affiliation. Photographer/Recorder shall conduct all of its activities in compliance with and pursuant to Title 49, Part 21 of the Code of Federal Regulations

(Nondiscrimination in Federally-Assisted Programs of the Department of Transportation - Effectuation of Title VI of the Civil Rights Act of 1964), as said regulations may be amended.

9. Photographer/Recorder agrees to indemnify, hold harmless, defend and insure the Airport and its agents and employees, from and against any and all claims and causes of action, administrative proceedings, judgments, penalties, fines, damages, losses, demands, liabilities, or expenses whatsoever (including reasonable attorney's fees and costs of litigation, mediation and/or administrative proceedings) which may be brought, alleged, or imposed arising directly or indirectly from or in any way connected with (1) any property damage or loss, personal injury, including death, or adverse effect on the environment, arising out of Photographer/Recorder's action or inaction with regard to the operations of Photographer/Recorder hereunder (subject only to the terms and conditions set forth in paragraph 7, above); (2) the failure of the Photographer/Recorder, its agents or employees, to comply with these terms and conditions, or to comply with any applicable federal, state, or local laws, rules, regulations, ordinances, or orders including, but not limited to, any and all applicable environmental laws, rules, regulations, or orders (Photographer/Recorder shall have a reasonable time to cure any noncompliance within a reasonable period following notice, but shall be responsible for indemnity under this paragraph for any loss accrued prior to complete cure); and/or (3) release of any hazardous or regulated substances or waste onto, into, or from the Airport, connected in any way with Photographer/Recorder's operations or action or inaction of Photographer/Recorder, its agents or employees, regardless of whether the act, omission, event, or circumstance constituted a violation of applicable law at the time of the occurrence.
10. Airport acknowledges that as between Airport and Photographer/Recorder, Photographer/Recorder shall have the right to, and to license others to reproduce, edit, distribute, exhibit, advertise, publicize, promote and otherwise exploit the Series in any and all media, whether now known or hereafter devised, throughout the universe in perpetuity and in connection therewith to use or authorize the use of any portion(s) of the Series containing those Photography/Recordings in other television productions, motion pictures, or digital platforms. As between Airport and Photographer/Recorder, Photographer/Recorder shall be the sole owner of all right, title and interest, under copyright or otherwise, in the Series and all Photography/Recordings made by the Photographer/Recorder of the Airport, whether or not included in the Series.
11. Photographer/Recorder shall have no obligation to make any Photography/Recordings on or of airport, to produce or exploit the Series or to include Photography/Recordings of the Airport in the series or in any advertising, publicity or promotion for the Series.
12. Airport represents that this consent is the sole authorization required from the State of Alaska for the making of Photography/Recordings on or of Airport, provided that the Photographer/Recorder and its activities are conducted in compliance with generally applicable law.
